## FOR HYDROCARBON REFRIGERATION UNITS

## WARNING

This unit uses R-290 (propane), or R-600a (isobutane) as a refrigerant. These hydrocarbon refrigerants are highly environmentally compatible but also are flammable and combustible. Please read this manuel thoroughly before installing and operating the unit. Please take cautious measures to avoid risk of fire or explosion.

## PLEASE REFER TO THE LABEL INSIDE THE CABINET TO CHECK REFRIGERATION TYPE AND VOLUME.

DANGER - Risk of fire or explosion. Flammable refrigerant used. Do
not use mechanical devices to defrost refrigerator. Do not puncture
refrigerant tubing.

## FOR HYDROCARBON REFRIGERATION UNITS

## $\triangle$ WARNING

- Handle the unit with care in order to avoid any serious damage to the refrigeration system.
- The refrigerant tubing, condenser, and evaporator coils are easily prone to damage while handling, moving, installing, and cleaning the unit, which may lead to fire or even explosion.
- Refrigerant squirting out of the pipes could ignite or cause an eye injury. If a leak is detected, avoid any naked flames or potential sources of ignition and air the room in which the appliance is standing for several minutes.
- In order to avoid the creation of a flammable gas-air mixture in case of a leak in the refrigerating circuit, the size of the room in which the appliance is placed depends on the amount of refrigerant used. The room must be $35.31 \mathrm{ft}^{3} 1 \mathrm{~m}^{3}$ in size for every $0.28 \mathrm{oz}(8 \mathrm{~g})$ of R-290 refrigerant inside the appliance. The amount of refrigerant in your particular appliance is shown on the label inside the cabinet.

This appliance contains a small amount of propane (R-290) or isobutane (R-600a) refrigerant, a natural gas with high environmental compatibility, but which is also combustible. When transporting and installing the appliance, care should be taken to ensure that no part of the refrigerating circuit is damaged.

- Never start up an appliance showing any signs of damage. If in doubt, contact a qualified service professional.
- In case of any hazardous activities such as fire or explosion, move the unit away from any source of ignition to a well ventilated area.
- Further service and repair must be done by a qualified technician who is familiar with the safety standards, and also has thorough understanding and knowledge of the flammable refrigerants.
- Any and all technicians handling these units must be equipped with proper personal protection and equipment and follow applicable safety measures and precautions to avoid risk of fire or explosion.

## $\triangle$ WARNING

## INSTALLATION INSTRUCTIONS

## DAMAGE INSPECTION

Prior to installation, the customer must check for damages with the freight company before the unit is accepted.

1. If the crate is damaged, make sure to note the damage on the Bill of Lading prior to signing the delivery off.
2. Concealed damage must be reported within 5 days of receiving the unit. Bill of Lading must be faxed to the Claims department. Pictures of both unit and crating may be requested.

## LOCATING THE DISPLAY MERCHANDISER

Display Merchandisers are designed to be in an area that is ambient 75 degrees Fahrenheit (dry bulb) or colder with 55 percent relative humidity. If the installed unit is in a warm ambient area, it may not be as effective. Position the Merchandiser at its final location before removing the shipping skid. There are four bolts at the bottom of the merchandiser that secure the shipping skid. Remove all four bolts to remove the skid. Allow three inches of space from the wall to the back of the merchandiser. Condenser is located to the front. Do NOT block inlet.

## LEVELING THE OPEN DISPLAY MERCHANDISER

Four leveling legs are provided to level your Merchandiser. Use a leveler to ensure the unit is evenly leveled on all four corners. If the unit is not leveled correctly, excess water buildup will not drain properly. If you do not wish to use the levelers, they can be turned inwards.

## SEALING CABINET TO FLOOR OR COUNTERTOP

It shall be sealed the Cabinet to the floor for floor sealed type, or to countertop for countertop sealed type unit. According to the following methods.

- Clean the floor or countertop.
- Install the cabinet to proper location.
- Adjust and make sure the cabinet in level position, and the gap between the bottom of cabinet and the floor or countertop not exceed $1 / 8 \mathrm{in}(3.2 \mathrm{~mm})$
- Use proper sealant such as fluorocarbon aliphatic resin sealant to seal all 4 bottom of cabinet to the floor or countertop.

- Sealant to seal after the cabinet locate in proper location.

Turbo Air Recommended Operating Conditions


- Units should not be placed in direct sunlight.

- Units should not be placed near doorways.


-Level the cabinet on all four corners of the base.

- Operating environment not to exceed $75^{\circ} \mathrm{F}$ (24 ${ }^{\circ} \mathrm{C}$ ) and $55 \%$ humidity.
-Do not load product beyond the edge of the shelf


## OPERATING INSTRUCTIONS

Level and set your merchandiser in place. Connect all necessary electrical connections. Your Display Merchandiser should now be ready for use.

## HOW TO SET THE TEMPERATURE

1. Press the SET button sat for $1 S$ to check the temperature setting.
2. The display panel shows the current temperature setting.
 the SET sems button when adjustment is complete.
3. The temperature setting has been changed and the display panel shows the current temperature.

## MANUAL DEFROST

1. Press the DEFROST button $\nabla_{\nabla} \frac{\text { 粦 }}{*}$ for $3 S$ to begin a manual defrost.
2. Defrost mode will turn off automatically when it is complete.
3. During the defrosting process, pressing the DEFROST button $\nabla_{\nabla}^{\frac{3 *}{* *}}$ for $3 S$ will stop defrosting and turn off the defrost mode

## NOTE:

- Do not place products into your merchandiser until the desired temperature is reached.
- Do not place hot products into the merchandiser.


## PRODUCT PLACEMENT:

Overloading of product or placing products against the back wall or suction grill may cause disruption in air flow, which may cause the unit to not cool properly.

## MAINTENANCE \& CLEANING

Always turn off your unit (both power and lights) when cleaning. Remove all products and allow your unit to reach room temperature. Do not allow electrical components to get wet.

## CLEAN YOUR DISPLAY MERCHANDISER THOROUGHLY BEFORE FIRST USAGE.

a. Do not clean with harsh detergents. Use mild soap.
b. Remove all products.
c. Remove shelves and bottom trays.
d. Clean interior with warm water and mild detergent.
e. Wipe with damp cloth. Do not leave soap residue.

## CLEANING THE CONDENSER COIL

How to remove Louver.


1. Disconnect the electrical power from the unit.
2. Lift up the Louver to release from the body.(1))
3. Pull the Louver toward you.(2))
4. Pull down.(3)
5. Brush off dust and lint from the finned condenser coil.
6. When finished, install louver in reverse order of remove.
7. Reconnect the electrical power to the unit.
8. Condenser should be cleaned every month or as needed.

## TROUBLESHOOTING

For any problems concerning your unit, please refer to the following check list. If you are still experiencing problems or have questions, please call the Customer Service line at 1-800-381-7770.

## I . MERCHANDISER NOT FUNCTIONING

a. Check to see that the breaker hasn't tripped.
b. Check that enough power is BEING supplied to the unit.
c. Check that the power switch is on.

## II . MERCHANDISER IS WARM

a. Check the condenser to see if it is clean.
b. Check that the inner airflow is not being blocked by products.

## III . LIGHTS ARE NOT WORKING

a. Check that light switch is on.
b. Check that the lights are placed in the lamp holders correctly.

## TWO (2) YEAR WARRANTY

## Warranty Claims...

All claims for parts or labor must be made directly through Turbo Air. All claims should include: model number of the unit, the serial number of the cabinet, proof of purchase, date of installation, and all pertinent information supporting the alleged defect. In case of compressor replacement under warranty, either compressor or compressor tag must be returned to Turbo Air along with above listed information.
Failure to comply with warranty policies will result in voiding claims.

## Two-Year Parts \& Labor Warranty...

Turbo Air warrants all new refrigerated components, the cabinet and all parts, to be free from defects in materials or workmanship, under normal and proper use and maintenance service as specified by Turbo Air and upon proper installation* (indoor building only) and start-up in accordance with the instruction packet supplied with each Turbo air unit. Turbo Air's obligation under this warranty is limited to a period of two (2) years from the date of original installation or twenty seven (27) months after shipment date from Turbo Air, whichever occurs first. Any part, covered under this warranty, that is by Turbo Air to have been found defective within two (2) years of original installation or twenty seven (27) months after shipment date from manufacturer, whichever occurs first, is limited to the repair or replacement, including labor charges, of defective parts or assemblies. The labor warranty shall include standard straight time labor charges only and reasonable travel time, as determined by Turbo Air. (*Installation in unstable, mobile, and enclosed area may not be considered as proper installation.)

## Additional Three-Year Compressor Warranty...

In addition to the two (2) year warranty stated above, Turbo Air warrants its hermetically sealed compressor to be free from defects in both material and workmanship under normal and proper use and maintenance service for a period of three (3) additional years from the date of original installation, but not to exceed five (5) years and three(3) months after shipment from the manufacturer. Compressor determined by Turbo Air to have been defective within this extended period will, at Turbo Air's discretion, be either repaired or replaced with a compressor or compressor parts of similar design and capacity.

The three (3) year extended compressor warranty applies only to hermetically sealed parts of the compressor and does not apply to any other parts or components, including, but not limited to, cabinet, paint finish, temperature control, refrigerant, metering device, driers, motor starting equipment, fan assembly and/or other electrical components, etcetera.

## R-290/R-600a Hydrocarbon Compressor Warranty...

The three-year compressor warranty detailed above will be void if the following procedure is not carefully adhered to:

1. This system may contain R290 refrigerant and polyol ester lubricant.

The polyol ester lubricant has rapid moisture absorbing qualities. If long exposure to the ambient conditions occur, the lubricant must be removed and replaced with new.
2. Drier replacement is very important and must be changed when a system is opened for servicing. Drier with XH-7 molecular sieve or better must be used.
3. Micron level vacuums must be achieved to ensure low moisture levels in the system. 500 microns or lower must be maintained.
4. Compressor must be obtained through Turbo Air, unless otherwise specified in writing, through Turbo Air's warranty department.
